RESEARCH PROJECTS

Current

Governance of Cybersecurity. Not only after the rise of the Islamic State in Syria and Iraq and the recent terrorist attacks in Paris, cyber security has become a top priority for policy makers and the intelligence community on both continents. This project investigates how the governance of cyber security policy differs in Europe and the U.S., which (state and non-state) actors are involved in the process and to what extent national security concerns such as terrorist attacks impact the decision-making process.

Democracy promotion in the Middle East and North Africa. This book project with PalgraveMacmillan compares the impact of U.S. and EU democracy promotion policy in several countries in the Middle East and North Africa.

Global actors and regional conflict. In collaboration with the Institute for European Politics (IEP) in Berlin, this project compares how the EU responds to and interferes in conflicts in Syria, the Middle East, Ukraine, and Armenia with responses from governments in China, the U.S. and Russia. An edited volume and/or special issue is planned to be published in 2017.

Completed

Europe, institutional change and the Middle East. The European Union (EU) changes states. That is not only true for those countries directly involved in the process of European integration, but also for Europe's neighborhood. This dissertation project offers an actor-centered approach to analyze and measure European impact where it is more unlikely to be found; in Europe's southern neighborhood. The results of this project are published as the monograph *The Wind of Change: European Neighborhood Policy, institutional change and domestic actors in Morocco*, VS Springer, 2016.

Logics of Action in the Mediterranean. I contributed to an exciting research project with Prof. Annette Juenemann from the Helmut Schmidt University in Hamburg, Germany. In collaboration with researchers from the University of Marburg (Germany), St. Andrews University (UK) and University of Southern Denmark, we looked beyond the traditional models of international cooperation and revealed the logics of action in the Middle East and North Africa after the Arab Spring protests. The results of the project were published as the edited volume *Euro-*

Mediterranean Relations after the Arab Spring : Persistence in Times of Change with Ashgate in 2013.

Policy Change in Europe's neighborhood. This policy-focused book project brought together junior academics and practitioners working on the EU's relationship with its neighborhood. The published edited volume edited by Katrin Böttger (Institute for European Politics) and Tanja Börzel (Free University) *Policy Change in the EU's Immediate Neighbourhood: A Sectoral Approach* published by Nomos included policy focused articles each focusing on a different neighboring country or region.
